**DIRECTORS REPORT**

---

The directors present their annual report and the audited financial statements of the company for the financial year ended 31 December 2020.

**Company secretary**

The company secretary throughout the financial year was Joe Murray.

**Principal activities**

The principal activity of the company is to support people in need in the Global South and Ireland, especially those affected by poverty, war or climate change.

**Review of the business**

The company receives funds from donors, some of which are restricted to specific works. Restricted funds received included those from Irish Aid, Trócaire, Concern and WorldWise Global Schools. These funds are restricted to Development Education. Irish Quaker Faith in Action funds are restricted to work on anti-militarisation themes. Unrestricted funds are funds collected locally.

**Change of name**

The company changed its name from "AFRI Company Limited by Guarantee" to "AFRI" by special resolution passed at the extraordinary general meeting held on the 20 February 2018 and approved by the Companies Registration Office.

**Results**

The deficit for the financial year amounted to €12,968 (2019 : surplus €3,460) and this was transferred from/to reserves at the year end.

**Afri Highlights 2020**

The year 2020 started off like any other - Féile Bríde, came and went with it's usual message of new hope and new beginnings.

We had the school's campaign and the Carlow famine walk, which was particularly successful with a large attendance and representatives of many different groups and Institutions. The idea of making the Famine graveyard a place of biodiversity was proposed by Afri and embraced by our partners in IT Carlow and Carlow County Council.

And then everything changed dramatically as lockdowns, face covering, social distancing, PPE, flattening the curve and sanitising became the order of the day! The question then became how does Afri's work continue in these challenging new circumstances. Things shifted quickly from working in the office to working at home, from meetings in person to meetings on zoom and on skype.

Afri showed dexterity and flexibility and became a 'leader in the field' in terms of making the transition to online platforms. Great credit is due to the Afri Board for their support but especially to Larysa, who worked from Belarus for a number of months and RoJ, both of whom showed tremendous resilience, creativity and commitment throughout this whole period. Also special thanks to Ruairi McKiernan who lent us his expertise in relation to online activity and social media.

Our first major event after the lockdown was announced was the Famine Walk. Our initial thought was cancellation but then we decided to do an online version, which required a radical change in our thinking and a very significant leap of faith. But it was a great success, with three hundred people joining from twelve countries including India, El Salvador and Brazil and two thousand people viewing it within the following 24 hours.

Our outdoor classroom event with students in Galway was replaced by a small gathering and the production of a film on Direct Provision, entitled 'Ireland of the Welcomes', featuring Donnah Vuma, Wasakera Sekerani and Donal O'Kelly. Likewise, our outdoor classroom event in Dunshaughlin was replaced by a similar small gathering and the production of a film on the theme of An Gorta Mór and biodiversity. This film included interviews with Oisín Coghlan of Friends of the Earth and student climate activist Gráinne Malone. These films were viewed by nearly a thousand people on our youtube channel, far in excess of the number that would've attended the actual events.

Instead of the usual Food Sovereignty Assemblies in Maynooth and Castlebar, we brought both together in a very successful online event.

One of the highlights of the year was our support for Colm Roddy and Dave Donnellan through their trial and acquittal of all charges - relating to their protest at the presence there of the "murderous machinery" of the US military at Shannon Airport. After a nine-day trial at Dublin Circuit Criminal Court, the jury of eleven men and one woman took a little under two hours to return unanimous verdicts of not guilty on the charges of criminal damage of the airport perimeter fence and runway

We had a very successful online 'Hedge School' with students and staff from TUD Blanchardstown on the themes of Racism, Conflict and Climate Change. There were great contributions from students including a first for Afri - puppetry as a development educational methodology.

We also published a series of excellent new educational resources including 'Interdependence Day' by Pete Mullineaus; The Web of Life by Nicola Winters and Pleannanna Ceachta as gaeilge' translated by Mark Doris. And our first ever Calendar for sustainability with monthly suggestions for how to live sustainably and tackle the climate and biodiversity crises was produced.

Meanwhile, our partnerships with Development Pamoja and the Kenya Pastoralist Journalists Network continues - providing solar lights for families, promoting food sovereignty and supporting education and awareness around the Covid Pandemic.

On Corporate Governance, we continued to maintain compliance with the Governance Code and in 2019 prepared for the implementation of the Charity Regulator's new Code of Governance for Charities. We also reviewed, in consultation with Emer Lynam, a number of our policies to ensure compliance with relevant legislation.

### **Governance, Risks and Reserves**

The Board is committed to maintaining the highest standards of Corporate Governance and as a member of Dóchas, is a signatory of the Irish Development NGO's Code of Corporate Governance. In 2013, Afri decided to adopt the Governance Code and joined a Corporate Governance working group run by IDEA to work towards meeting the standards of the Code. Afri was deemed to be meeting the terms of the Code from 27 September 2017. As part of the terms each year, we are required to self-assess our practices against those recommended in the Code and for this review to be approved by the Board. At the end of three years, (i.e. by 27 September 2020) Afri was required to inform the Governance Code in writing that the Board still considers that we are compliant with the Code. The Board approved this review and Afri informed the Governance Code in writing that we are compliant with the Code.

Board members, all of whom are non-executive, are drawn from diverse backgrounds in education and the NGO sector and bring a broad range of experience and skill to the Board. Afri is aware of the need to maintain a broad range of skills and experiences on the Board and is committed to ensuring diversity.

There are clear distinctions between the role of the Board and the Executive Management Team (in consultation with the Financial Consultant, where appropriate) for consideration and approval by the Board, who then monitor the implementation of these plans. The Board is responsible for deciding the objectives of Afri and formulating policies to achieve those objectives and to safeguard its core values and principles.

All newly appointed Directors are furnished with a document outlining their responsibilities and with the Constitution of Afri.

Under the governing documents, Directors are not entitled to any remuneration. They may be reimbursed for expenses incurred in the course of carrying out their duties. Conflicts of interest and loyalty must be declared and a 'register of interests' is maintained at the registered office.

The Board is aware of the importance of accountability in terms of reporting to funders and to members of the public and is committed to having systems in place to enable oversight. While the Board is involved in monitoring the activities of Afri and responding to any challenges when they arise, it has been agreed that it would be useful to formulate a specific plan to deal with any challenges that Afri may face, in line with best corporate governance practice. Accordingly, the Board has formulated an organisational risk register which identifies specific challenges that Afri faces. This risk register is reviewed on a regular basis.

The directors are conscious of the need to incur expenditure prudently and will continue to monitor the level of income and expenditure in the foreseeable future. Accordingly, a Reserve policy was formulated to ensure that Afri can maintain adequate resources to finance the ongoing work of Afri which is not covered by grants received from donors, while maintaining a prudent approach in the use of such resources. Afri aspires to maintain reserves at a level equivalent to three months' running costs.

**Events after the end of the reporting period**

There have been no significant events affecting the company since the year end.

**Research and development**

The company did not engage in any research and development activity during the year.

**Accounting records**

The measures taken by the directors to secure compliance with the requirements of sections 281 to 285 of the Companies Act 2014 with regard to the keeping of accounting records are the implementation of necessary policies and procedures for recording transactions, the employment of competent accounting personnel with appropriate expertise and the provision of adequate resources to the financial function. The accounting records of the company are located at the registered office.

**Relevant audit information**

They are also responsible for safeguarding the assets of the company and hence for taking reasonable steps for the prevention and detection of fraud and other irregularities.

### **Report on the audit of the financial statements**

#### ***Opinion***

We have audited the financial statements of AFRI ('the Company') for the financial year ended 31 December 2020 which comprise the income and expenditure account, statement of income and retained earnings, balance sheet and notes to the financial statements, including the summary of significant accounting policies set out in note 2. The financial reporting framework that has been applied in their preparation is Irish law and FRS 102 The Financial Reporting Standard applicable in the UK and Republic of Ireland issued in the United Kingdom by the Financial Reporting Council.

In our opinion, the financial statements:

- give a true and fair view of the assets, liabilities and financial position of the company as at 31 December 2020 and of its deficit for the financial year then ended;
- have been properly prepared in accordance with FRS 102 The Financial Reporting Standard applicable in the UK and Republic of Ireland; and
- have been properly prepared in accordance with the requirements of the Companies Act 2014.

#### ***Basis for opinion***

We conducted our audit in accordance with International Standards on Auditing (Ireland) (ISAs (Ireland)) and applicable law. Our responsibilities under those standards are described below in the Auditor's responsibilities for the audit of the financial statements section of our report. We are independent of the company in accordance with the ethical requirements that are relevant to our audit of the financial statements in Ireland, including the Ethical Standard for Auditors (Ireland) issued by the Irish Auditing and Accounting Supervisory Authority (IAASA) and we have fulfilled our other ethical responsibilities in accordance with these requirements.

In auditing the financial statements, we have concluded that the directors' use of the going concern basis of accounting in the preparation of the financial statements is appropriate.

Based on the work we have performed, we have not identified any material uncertainties relating to events or conditions that, individually or collectively, may cast significant doubt on the Company's ability to continue as a going concern for a period of at least twelve months from the date when the financial statements are authorised for issue.

Our responsibilities and the responsibilities of the directors with respect to going concern are described in the relevant sections of this report.

***Other Information***

The directors are responsible for the other information. The other information comprises the information included in the annual report, other than the financial statements and our auditor's report thereon. Our opinion on the financial statements does not cover the other information and, except to the extent otherwise explicitly stated in our report, we do not express any form of assurance conclusion thereon.

Our responsibility is to read the other information and in doing so, consider whether the other information is materially inconsistent with the financial statements or our knowledge obtained in the course of the audit, or otherwise appears to be materially misstated. If we identify such material inconsistencies or apparent material misstatements, we are required to determine whether there is a material misstatement in the financial statements or a material misstatement of the other information. If, based on the work we have performed, we conclude that there is a material misstatement of this other information, we are required to report that fact.

We have nothing to report in this regard.

**NOTES TO THE FINANCIAL STATEMENTS  
FOR THE FINANCIAL YEAR ENDED 31 DECEMBER 2020**

---

**1. General information**

The financial statements comprising the income and expenditure account, statement of income and retained earnings, balance sheet and the related notes constitute the individual financial statements of AFRI for the financial year ended 31 December 2020.

AFRI is a private company limited by guarantee (registered under Part 2 of Companies Act 2014), incorporated and registered in the Republic of Ireland (CRO number 251696). The registered office is 8 Cabra Road, Dublin 7, D07 TIW2, which is also the principal place of business of the company. The nature of the company's operations and its principal activities are set out in the Directors' Report.

**Statement of compliance**

The financial statements have been prepared in accordance with FRS 102 "The Financial Reporting Standard applicable in the UK and Republic of Ireland" (FRS 102), applying section 1A of that Standard.

**Currency**

The financial statements have been presented in the Euro currency (€) which is also the functional currency of the company.

**2. Summary of significant accounting policies**

The following accounting policies have been applied consistently in dealing with items which are considered material in relation to the company's financial statements.

**Basis of preparation**

The financial statements have been prepared on the going concern basis and in accordance with the historical cost convention modified to include certain items at fair value. The financial reporting framework that has been applied in their preparation is the Companies Act 2014 (the Act) and FRS 102 The Financial Reporting Standard applicable in the UK and Republic of Ireland issued by the Financial Reporting Council. The company qualifies as a small company for the period, as defined by section 280A of the Act, in respect of the financial year, and has applied the rules of the 'Small Companies Regime' in accordance with section 280C of the Act and Section 1A of FRS 102.

**Income**

Income consists of donations and other funds received and receivable and is recognised when the company is entitled to the income legally, virtually certain of receipt and when the amounts involved can be measured sufficiently and reliably. Income from grants is recognised only when the related expenditure is incurred. The balance of the grant not expended is deferred until the following year.

**Taxation**

No charge to current or deferred taxation arises as the charity has been granted charitable status under Sections 207 and 208 of the Taxes Consolidation Act 1997, Charity No CHY 7627. The charity is eligible under the "Scheme of Tax Relief for Donations to Eligible Charities and Approved Bodies under Section 848A Taxes Consolidation Act, 1997" therefore income tax refunds arising from sponsorships exceeding €250 per annum are included in unrestricted funds. Irrecoverable value added tax is expended as incurred.

---

**Tangible assets**

All tangible fixed assets are initially recorded at historic cost. This includes legal fees, stamp duty and other non-refundable purchase taxes, and also any costs directly attributable to bringing the asset to the location and condition necessary for it to be capable of operating in the manner intended by management, which can include the costs of site preparation, initial delivery and handling, installation and assembly, and testing of functionality.

**Depreciation**

Depreciation is calculated so as to write off the cost or valuation of an asset, less its residual value, over the useful economic life of that asset as follows:

Office equipment	- 20%	reducing balance
Fixtures and fittings	- 20%	reducing balance

The residual value and useful lives of tangible assets are considered annually for indicators that these may have changed. Where such indicators are present, a review will be carried out of the residual value, depreciation method and useful lives and these will be amended if necessary. Changes in depreciation rates arising from this review are accounted for prospectively over the remaining useful lives of the assets.

**Impairments of assets, other than financial instruments**

A review for indicators of impairment is carried out at each reporting date, with the recoverable amount being estimated where such indicators exist. Where the carrying value exceeds the recoverable amount, the asset is impaired accordingly. Prior impairments are also reviewed for possible reversal at each reporting date.

When it is not possible to estimate the recoverable amount of an individual asset, an estimate is made of the recoverable amount of the cash-generating unit to which the asset belongs. The cash-generating unit is the smallest identifiable group of assets that includes the asset and generates cash inflows that are largely independent of the cash inflows from other assets or groups of assets.

**Critical Accounting Judgements and Estimates**

The company makes estimates and assumptions concerning the future. The resulting accounting estimates will, by definition, seldom equal the related actual results. The estimates and assumptions that have a significant risk of causing a material adjustment to the carrying amounts of assets and liabilities within the next financial year are discussed below.

Establishing useful economic lives for depreciation purposes of office equipment, fixtures and fittings long-lived assets, consisting primarily of office equipment, fixtures and fittings comprise a significant portion of the total assets. The annual depreciation charge depends primarily on the estimated useful economic lives of these assets and change them as necessary to reflect current thinking on remaining lives in light of prospective economic utilisation and physical condition of the assets concerned. Changes in asset useful lives can have a significant impact on depreciation and amortisation charges for the period. Detail of the useful economic lives is included in the accounting policies.

---

**Financial instruments**

A financial asset or a financial liability is recognised only when the company becomes a party to the contractual provisions of the instrument.

Basic financial instruments are initially recognised at the transaction price, unless the arrangement constitutes a financing transaction, where it is recognised at the present value of the future payments discounted at a market rate of interest for a similar debt instrument.

Debt instruments are subsequently measured at amortised cost.

Where investments in non-convertible preference shares and non-puttable ordinary shares or preference shares are publicly traded or their fair value can otherwise be measured reliably, the investment is subsequently measured at fair value with changes in fair value recognised in profit or loss. All other such investments are subsequently measured at cost less impairment.

Other financial instruments, including derivatives, are initially recognised at fair value, unless payment for an asset is deferred beyond normal business terms or financed at a rate of interest that is not a market rate, in which case the asset is measured at the present value of the future payments discounted at a market rate of interest for a similar debt instrument.

Other financial instruments are subsequently measured at fair value, with any changes recognised in profit or loss, with the exception of hedging instruments in a designated hedging relationship.

Financial assets that are measured at cost or amortised cost are reviewed for objective evidence of impairment at the end of each reporting date. If there is objective evidence of impairment, an impairment loss is recognised in profit or loss immediately.

For all equity instruments regardless of significance, and other financial assets that are individually significant, these are assessed individually for impairment. Other financial assets are either assessed individually or grouped on the basis of similar credit risk characteristics.

Any reversals of impairment are recognised in profit or loss immediately, to the extent that the reversal does not result in a carrying amount of the financial asset that exceeds what the carrying amount would have been had the impairment not previously been recognised.

**Defined contribution plans**

The company operates a defined contribution scheme. Retirement benefit contributions in respect of the scheme for employees are charged to the income and expenditure account as they become payable in accordance with the rules of the scheme. The assets are held separately from those of the company in an independently administered fund. Differences between the amounts charged in the income and expenditure account and payments made to the retirement benefit scheme are treated as assets or liabilities.

Once-off termination payments that are not required by contract, legislation, or other obligations or commitments, are recognised in the financial year in which they become payable.

**3. Limited by guarantee**

The liabilities of the members is limited.

Every member of the company undertakes to contribute to the assets of the company in the event of its being wound up while they are members, or within one year thereafter, for the payment of the debts and liabilities of the company contracted before they ceased to be members, and of the costs, charges and expenses of winding up, and for the adjustment of the rights of the contributors among themselves, such amount as may be required, not exceeding €1.00.

**4. Staff costs**
